They can meet local artists and craftsmen, which can broaden their understanding of different concepts and traditions, and help them appreciate the importance of preserving heritage. More importantly, it helps to inculcate a love for going to school every day. When students enjoy their school experience, they are more likely to be motivated to learn and to develop a lifelong love for education.
